During this period, I added my data analysis, a completed methodology and introduction. I've decided to focus on the resistance to the hegemonic identity among young people in Hong Kong, which will be determined from an online article called "Diversity of Youth Aspirations" and primary data. The main published ethnography that I will be basing my research is called "Hip-Hop: Japan" by Ian Condry. I chose to use this ethnography as my area of research is relatively new, leading to lack of data in the Hong Kong context. I also collected primary data to support my data analysis from local hip-hop artists. I found it hard to collect primary data as there may be errors in translating the Cantonese to English in my transcriptions of th interviews. I sent my transcription to the interviewees so that they can confirm that my translations were accurate. Furthermore, I found it difficult to explain and analyze my data using anthropological theoretical perspectives as real life examples usually tend to be more complex as suggested in anthropological theories. In order to overcome this, I used multiple theories to match my data analysis.
